

HeartEye Village CSA Produce Purchaser Agreement

The following are the agreements between:

HeartEye Village CSA, LLC (hereinafter, the Farm) and
_____ (hereinafter, Purchaser).

1. The Farm will provide, unprocessed, organically grown produce to the Purchaser once a week for 16 weeks from approximately the 1st week of June 2011 until approximately the 4th week of September 2011. _____

2. The Purchaser or his/her agent is responsible for picking up the harvested produce at the garden studio cabin at 10364 Araphaoe Rd, Lafayette CO 80026, on Thursday between 4:30 and 6:00 p.m. _____

3. Any share that is not picked up by the designated times (unless we are notified otherwise) will be donated to a charity of the Farm's choice or a designated needy family or otherwise allotted at the Farm's discretion. (See item 8 below). _____

4. This agreement acknowledges (choose one):

_____ the payment by Purchaser of \$450 for a whole produce share (feeds 2 people).

_____ the payment by Purchaser of \$225 for a half produce share (feeds 1 person).

_____ the payment by Purchaser of \$450 for a whole produce share, paid in full by May 5, 2011 (in 3 installments due 3/1/11, 4/1/11, & 5/1/11).

_____ the payment by Purchaser of \$225 for a half produce share, paid in full by May 5, 2011 (in 3 installments due 3/1/11, 4/1/11, & 5/1/11).

_____ the commitment by Purchaser to work in the garden under the supervision of the garden manager, for 72 hours between Feb 15, 2011 and October 15, 2011 for a whole produce share, scheduled in advance such that 1/3 of the time commitment is completed by June 1, 2011 and 2/3 of the time commitment is completed by Aug 15, 2011.

_____ the commitment by Purchaser to work in the garden under the supervision of the garden manager, for 36 hours between Feb 15, 2011 and October 15, 2011 for a half produce share, scheduled in advance such that 1/3 of the time commitment is completed by June 1, 2011 and 2/3 of the time commitment is completed by Aug 15, 2011.

5. If Purchaser chooses payment of share in installments and if Purchaser fails to pay in full by May 5, 2011, Purchaser forfeits their produce share and will be refunded any installments made previously to May 1, 2011 as per paragraph 9 below. If Purchaser chooses the commitment to work in the garden in lieu of payment for their produce share and fails to fulfill the labor commitment, Purchaser will be required to pay the balance of the cost of the remainder of the produce share or forfeit their share. _____

6. Based upon the season and the contingencies of farming (e.g. extreme temperatures, hail, wildlife damage, pests, drought, etc.) it is possible that the number of harvests and/or the produce share sizes may not meet the anticipated harvest goals of the managers of the Farm. Purchaser agrees to bear the risk of variable harvests or crop failures due to unfavorable conditions that are beyond the control of the managers of the farm. _____

7. Purchaser understands that the content of the produce share is unprocessed and unwashed and that Purchaser is responsible for the adequate cleaning and preparation of said content in order to render it fit for human consumption. Purchaser agrees to bear all risk of any illness acquired by

Purchaser or other people consuming the content of the Purchaser's produce share that results from consumption of any portion of produce share content. Purchaser also understands that customizing the content of produce shares to Purchasers' individual preferences is not possible.

8. The Purchaser may designate another person to receive their produce for any of the weeks covered by this agreement. The Purchaser will notify the Farm of the designated person so that we know who is authorized to pick up produce. _____

9. The Farm will refund the full amount of a produce share up until two weeks prior to the first pick up, less a \$25.00 cancellation fee. _____

I have read and agree with these provisions and have enclosed a check for the agreed amount.
